#### Christ Evangelical Lutheran Church Annual Congregational Meeting January 28, 2024

#### 1. Call to order

Council President Su Erickson called the 2024 Annual Congregational Meeting to order at 10:25 a.m.

#### 2. **Opening liturgy**

Pastor Jeff led the meeting attendees in prayer.

#### 3. Appointment of Tellers

President Erickson announced the tellers: David Bruce, Jim Hill, John Williams, and Wes Yost. Ann Bruce is the Parliamentarian.

#### 4. Approval of the minutes from the 2023 Annual Meeting Minutes and Dec. 10, 2023, Special Congregational Meeting

Elaine Carlson moved to accept the minutes of both meetings as presented in the Annual Report, Sherry Hassel seconded. Motion carried.

#### 5. Review of staff and council reports and 2023 audit report

President Erickson directed attendees to the staff and council reports in the meeting packet and asked if there were any questions. Hearing none, she proceeded with the agenda.

#### 6. Review of the 2023 Mission Spending Plan and Presentation of the 2024 Plan

John Brown presented the end-of-year financial report for 2023 and explained that the \$10,353 loss in the general budget was partly because of the \$140,000 that was spent for the sewer project. Some of the money that was used to pay for the sewer came from our designated funds which now total \$53,000. John then went over the different fund balances, gave a short explanation of the 2024 mission spending plan and asked for questions. There were none.

John stated that the council voted to recommend the 2024 MSP and to consolidate the designated funds into 3 categories: Solar, Outreach and Discretionary. Su explained the reasoning behind this move and recommended that the congregation address any concerns that they may have about this issue to council members.

#### 7. Declaration of quorum.

Su Erickson confirmed that a quorum was present with 68 members in attendance.

#### 8. Nominating committee report

Su presented the Nominating Committee report and asked for nominations from the floor. There were no nominations from the floor, so nominations were closed. The following people were nominated for council positions:

- a. Education 2-year term Magan Ratalsky
- b. Fellowship 2-year term Gene Myers
- c. Outreach 2-year term Su Erickson
- d. Worship and Music 2-year term Carol Moonan
- e. Youth 1-year term no candidate

Su then announced the following appointments: 2025 Audit Committee – Janell Jenson, Keith LeFevre, and Ron Nawrocki Secretary – Joann Wordell, and Treasurer - John Brown

### 9. Ratification of constitutional amendments C.12.01 and C13.02 which were approved in 2023

The congregation was reminded that we needed to finalize the changes to the constitution that were approved in 2023. Su asked for questions and there were none.

#### 10. Casting of written ballots

The written ballots were distributed to the congregation members. The ballots contained a vote for council positions, the Mission Spending Plan, the consolidation of designated funds and ratification of the Constitutional amendments C12.01 and C13.02.

#### 11. Update on transition process

Su has had conversations with Deacon Katie Kline at the synod office and she will assign a transition coach to help us get started. We will have a transition team first and then a call committee. If you would like to be part of the Transition team let Su know. The call committee has to be elected at a special meeting of the congregation.

#### 12. Update on sewer and solar projects

Su stated that updates are available on the church website for both sewer and solar projects. Because we have a 70-year-old building we will continue to have maintenance issues.

## 13. Recognition of outgoing council and committee members and other staff

Cher Johnson – Fellowship Joanne Mueske – Worship and Music Jim Harmon – Secretary/Vice-president Ann Bruce – Treasurer Audit Committee – Tom Reynolds, Darrel Bjornson, and Janell Jenson Nominating Committee – Gayle Denny, Cher Johnson, Magan Ratalsky, and Darrel Bjornson Communications manager – Renata Spanton-Jones Facilities manager and Pastor of Vida Nueva – Jonathan Gonzalez Director of Music and Worship – Miloy Canete Pastor – Jeff Gallen

#### 14. Election results

68 completed ballots were returned. All nominees were elected, the 2024 Mission Spending Plan and consolidation of designated funds were approved, and the constitutional amendments were ratified.

#### 15. Closing comments and prayer

Su asked for any comments or questions and seeing none, asked Pastor Gallen to offer a closing prayer.

#### 16. Adjournment

Brad Sornsin moved to adjourn the 2024 Annual Meeting and Dave Bruce seconded. Motion carried. The 2024 Annual Congregational Meeting adjourned at 11:04 am.

#### **Message from the Council President**

As I reflect on this past year, I am filled with gratitude for faith and the love and trust of the CELC community. 2024, a year of radical resilience...faith, the ability to trust and let go. Some people may call it a year of last events with Pastor Jeff before his retirement the end of October, and others may call it a time of transition, acknowledging the past and all the wonderful things that have happened in our community. We do not know what the future holds, but we can look forward to the opportunities before us.

I worked with the Grand Canyon Synod interim transition director, Katie Kline and Pastor Phil Gustafson was appointed CELC's transition coach. He met with the council in March and our transition team started working shortly after. Thank you to Ann Bruce (Chair), Olga Blanchard, Karen Olson, Patsy Blankenship, Jim Erickson Stevie Henderson, and Judy Turpen for serving on this team. The team has been putting together a CELC history and timeline, and the three Bible study groups are looking at Acts, 1 Corinthians and Nehemiah to see how vision, mission and core values are reflected in the passages and how they relate to CELC's vision, mission, and core values. The whole congregation will be involved in focus groups and more discussions around these topics before we prepare our Ministry Site Profile (MSP), the document used by the Office of the Bishop in finding a good match between a rostered minister and a congregation.

I continued conversations with Pr. Gustafson and Bishop Deborah Hutterer. She called Pastor Kim Sterner as our Interim Pastor, to preside over worship and the sacraments, as well as guide us in the process of calling a new pastor to CELC.

In October, we celebrated Pr. Jeff's twenty-six years of service at CELC. On Reformation Sunday, October 27, Bishop Hutterer participated in the service, confirming three of our youth, distributing communion, and leading the litany of farewell and Godspeed for Pr. Jeff.

There are not enough words to express my gratitude for the leadership of the staff and Council as they support the Word of God and serve CELC:

Jonathan, our Facilities Manager and Randy Heibel who keep our buildings in good running order. And the silent partners, you know who you are, who help with our landscape and outdoor areas, raking, trimming, cleaning up, and those of you who notice the little things that need repair or replacement and quietly take care of them.

Miloy Canete, Director of Music and Worship for his weekly devotion to planning worship and providing music, as well as special services with full orchestras and soloists. The music brings such joy to all.

Church Council members who guide activities in their areas and sit down monthly to review our finances and policies.

Our Congregation, full time members who endured the hot, hot summer, as well as seasonal members who escaped the heat, but returned to worship and volunteer in our ministries.

The volunteers (members and community friends) who show up weekly to fill and distribute food boxes to families in need and the people who cook meals for our I-Help participants.

I rejoice that we are able to share our campus facilities with four other churches and several support groups that help so many people. We are truly a community of faith in action.

I will leave you with words by Henri J Nouwen, from a January 1 Daily Meditation.

#### **Music and Worship Report from Miloy Canete**

It is my pleasure to share the highlights of another year of music ministry at Christ Evangelical Lutheran Church. Through the dedication of our musicians, the support of our congregation, and the grace of God, we have experienced a year full of beautiful worship and new opportunities for growth in our ministry.

#### Adoration Choir

The Adoration Choir has continued to lead our congregation in music from September to May with unwavering commitment and passion. This year, our choir had the privilege of performing two significant musical cantatas: one for Easter and another for Christmas. These cantatas were accompanied by a 16-piece orchestra, adding a special grandeur to our worship and deeply enhancing the celebration of these sacred seasons. Sadly, we experienced the loss of two members with the death of Alan Lentfer and Rita Block's move out of town. However, we were blessed to welcome two new members to our choir this year: Valerie Cosgrove and Pastor Kim Sterner. The choir has continued to strengthen the "one member, one mic strategy" to enhance our vocal leadership and musical clarity in our worship services. This has helped ensure that each voice is heard clearly, contributing to a more vibrant musical experience for our congregation. Lastly, under the leadership of Jim Erickson, our A/V team stays fully staffed with dedicated volunteers year-round.

#### Children and Youth Music

Our church's yearly Christmas pageant, led by our children and youth, was a resounding success. This cherished event continues to be a highlight of the Christmas season and was well-received by the congregation. We continue to offer piano lessons on Sunday afternoons to our neighborhood kids.

#### Music Repertoire and Hymn Introduction

Throughout the year, we have continued our tradition of introducing new hymns/songs each month to enrich our worship services. This is part of our ongoing effort to keep our worship vibrant and inclusive, offering opportunities for everyone to connect with God through music.

#### **Grand Piano Donation**

We are also deeply grateful for the generous donation of a grand piano to our church. It is a wonderful addition to our church's music program, and we look forward to using it for many years to come.

#### Looking Ahead

As we look forward to another year of ministry, I am filled with gratitude for all that we have accomplished together, and I am excited for what the future holds. Our music ministry continues to thrive, thanks to the dedication of our choir, musicians, and volunteers, as well as the support of the entire congregation. Together, we will continue to glorify God through music and worship, and I am honored to be part of this vibrant and thriving ministry.

#### **BUILDINGS AND GROUNDS**

**Sewer Project.** Cactus Plumbing and Air completed new underground sewer lines for Building A, where the original pipes were replaced. We submitted an insurance claim for the failed sewer system. The Hanover Group, our property insurance company, denied our claim. Building A's leaking and rusting 50-gallon hot water heater was replaced during this project.

**Solar Project.** Solar Covered Parking (SCP) became less and less responsive to communications via email and phone. Trips to their various locations throughout the valley revealed their business had closed. Their failure to deliver a solar system was reported to the Arizona Registrar of Contractors. This put SCP's contractor's license at risk of suspension and revocation. Another solar company, Sun Valley Solar Solutions (SVSS), submitted a proposal. Acting on our behalf, SVSS actively sought a person or group to purchase their system and provide a Power Purchase Agreement (PPA) for CELC to sign. The council plans to provide SVSS with financial information after the end of 2024. The PPA group, initially hesitant to support us, may reconsider CELC as a potential customer, if our financial information is convincing.

**Backflow Valves.** Metro Fire repaired three valves on one occasion, and only weeks later repaired two of the same valves a second time. This occurred after we had passed our annual valve inspection during which repairs were also made.

**Building A.** Handy Randy installed three new ventilation fans, one in each of the bathrooms. The bathrooms in Fellowship Hall received new sink fixtures, drains and water valves. The men's bathroom urinal clogged and received a new drain. A broken tile on the southeast corner was replaced by GR Taylor Enterprises. The replacement was under warranty.

**Building B**. The water shut-off valve outside the nurse's office sprung a leak. Tom Flores Plumbing recommended a new valve due to multiple leaks. The valve has been ordered, and installation is anticipated.

**Kitchen, Building B**. TJS Electric repaired the exhaust hood, which now activates the fire alarm when needed. Replacing a missing resistor in the exhaust hood's fire control system resolved some unexpected and inappropriate fire alarms. Averus West performed our annual exhaust hood cleaning which included the roof fan. We continue to use Simple Green monthly to clean the sink drains and the downstream pipes that lead to the outdoor grease collection tanks. The tanks are drained every six months by Ducks Septic Pump & Install. These measures prevent the pipes from clogging and help preserve the concrete grease tanks.

**Fire Prevention.** Metro Fire certified our kitchen exhaust hood, checked our fire extinguishers, refilled one extinguisher, and certified our building in compliance with the fire code. This also included checking our indoor fire suppression sprinkler system and the outdoor backflow prevention valves. Johnson Controls completed our Fire Alarm system inspection and CELC passed.

**HVAC Units.** One of Building B's failing HVAC units was replaced with a new unit by Masters and Sons. The company continues to service our fourteen HVAC units with filter changes and the required maintenance.

<u>Security.</u> Johnson Controls upgraded and installed new components to our key access system. Exiting the east door of the Building B sanctuary is now permitted after setting the alarm.

<u>**Parking Lot.</u>** The handicapped parking stall which had been dug up during the sewer project was recovered with new asphalt. One light pole near the east entrance started blinking and needed a new LED bulb. It was replaced by Handy Randy.</u>

**Deep Cleaning Day.** A hardy group of church members spent a morning focused on cleaning the inside and the windows of Building A. Afterwards lunch was served.

**Landscaping.** Plans are being considered to resurface the area immediately outside Building A that was dug up during the sewer project. A labyrinth has been suggested. Weeds were somewhat prolific early in the year, but the hot, record setting summer prevented their growth. Due to the heat, we lost a few bushes. The frontage palm trees were trimmed in the fall. Pocket gophers continue to occupy sizeable portions of our property. A repellant is being applied in small areas to begin to discourage them.

**Irrigation.** RV Landscaping replaced two solenoids in our irrigation junction boxes and repaired one of our leaking pipes. Several of our trickle irrigation pipes that have been leaking were capped above ground. These leaks continue to develop.

**Signage.** The Litchfield Road sign was changed to reflect the Christmas Cantata. It was also changed to display the Christmas Eve and Christmas Day services. A Christmas banner was ordered and will be strung between two palms, as also happens each year with our Easter banner.

**NFL Green**. The plan to use our donated astroturf on the eastern frontage area of our campus is not a long-term solution. Arizona Artificial Lawns evaluated our donation and said the product is too thin and is best used on a concrete surface. Attempts are in the works to donate our turf to an animal shelter. Disposal is also an alternative.

Maintenance Man, Jonathan Gonzales. Continue paying complements to our maintenance man, who is also a pastor of Vida Nueva, one of our renting churches. He continues to set up and tear down chairs and tables for scheduled events. He keeps our facilities sparkling both inside and out. His religious and public relations skills and grasp of both English and Spanish serve our community expertly. And he is willing to lend a hand to anyone on any project, often before we know we need him.

**THANK YOU!** Many church members have volunteered time, energy, and/or advice to plan and execute the projects that keep our church buildings operational and our grounds well-groomed and attractive. I heartily thank everyone who helped in any way.

#### Education

Sunday School is continuing to occur on the 2<sup>nd</sup> and 4<sup>th</sup> Sunday of every month, after the gospel is read and for the duration of the sermon. We have on average 7 children in attendance. Jen Cole assisted by taking the children that are in grade 4<sup>th</sup> and above to a separate room, which has been very helpful to provide a more age-appropriate curriculum and activities.

The students participated in several activities throughout the year, especially around the holiday time periods. In March, we did the Easter Egg hunt in between the morning services. In December, we performed a Christmas program for the congregation.

Lastly, we open the 'kids' corner' in the sanctuary. This space is designed to provide a creative area for children to interact with other young ones during service through coloring, drawing, reading, and games. The space is located to the front-left of the altar to engage the children as part of the service. There are chairs 'around' the kids' corner, so parents can monitor their young ones while participating in the service.

#### EVANGELISM

- 1. Simplification of the Visitor Questionnaire has benefited both visitors and CELC personnel needing this information.
- 2. We are happy to receive 4 new members this year.
- Sponsors have been assigned to each new member this year for about 4 weeks to answer questions and to introduce them to CELC members.
- 4. Awareness has been growing regarding the usefulness of wearing name tags regularly. We have been handing out stick-ons when needed to assist Interim Pastor Kim Sterner in recognizing us by name.

#### MEMBERSHIP

- 1. Calls, emails, and note cards remain standard communication for visitors, shut-ins, and those celebrating special milestones or in discomfort or crisis.
- 2. Advent/Christmas cards have again been sent by a group of CELC members.
- 3. Book Exchanges are popular with children and adults and will be held as frequently as possible. Overflow books as well as magazines are given to Veterans and their friends and families.
- 4. Ellory Christianson continues to provide crocheted prayer shawls and small God's Hugs to members, their families, and

friends in need.

- 5. The Members in Touch column in the Weekly Church Announcements continues to supply miscellaneous news and reminders.
- 6. The Women's Saturday morning Social in August was a pleasant way to cope With our excessive heat and reconnect with each other. Ardyce DuRand gave us new insight into the growing Outreach, and I-HELP programs.
- 7. The Angel Tree, set up for the third year in a row to benefit Bosom Buddies-Latinas breast cancer survivors, was a big success, gifting 29 ladies with things they would not buy for themselves.

#### **GOALS REACHED**

- 1. The church directory has had a major update. Paper directories are available on request.
- 2. Lists of CELC accomplishments have been made available seasonally as handouts to members and visitors.
- 3. An attractive, informative trifold brochure has been printed, given to members, mailed, and available to visitors on Sunday mornings.
- 4. Sponsors for prospective and new members are provided as needed to introduce new people to CELC members and answer questions in the period from member orientation through the next few weeks.
- 5. The Saturday afternoon Bible class has been formed for men and women not able to attend weekday Bible class. It remains small but available.
- 6. Increasing the use of name tags is an ongoing project, desirable now in our transition period for the new pastors as well as for visitors.
- 7. The Prayer List "re-do" is being addressed right now.
- 8. Maintaining awareness of member vulnerabilities like extreme heat and isolation are ongoing.

I want to highlight the many members who actively look for ways to help as well as those who come together when asked, in ways large and only seemingly small, to accomplish what gets done in Evangelism/Membership. It's such a pleasure to be part of the CELC council and congregation doing God's Work Our Hands.

The last time one of my bands performed for Fall Festival was before the COVID-19 year.

There was a marked contrast between the two. The former event was much better attended by a livelier crowd that danced up until the last song of the second set. The congregation seems to be aging and less animated, which means we need to adjust the entertainment for next year to be more in-tune with changing needs and requirements. - In 2024, CELC supported the ministries of Lutheran Social Services of the Southwest (LSS-SW), Pan De Vida, Spirit in the Desert, Mosaic, the Cactus Conference Youth and Young Adult program, and the Grand Canyon Synod through our benevolence giving.
- CELC provides overnight lodging for participants in the LSS-SW I-HELP (Interfaith Homeless Emergency Lodging Program) twice a week. Members and community members provide a hot meal, and clothing is offered through the generous donations we receive.
- Whenever there is a call for special needs and projects (monetary or items), CELC members contribute to meet those needs. Thank you to our generous congregation (and Thrivent dollars) for supporting Patsy Blankenship and the youth as they collected items and put together 200 Manna Bags for CELC members to distribute to the homeless. Once again, members supported our Angel Tree gifts for the Bosom Buddies Latina group. 28 women received special gifts for Christmas.
- CELC provides regular meeting space for support groups: AA, AZTypo, Bosom Buddies, Alzheimer's Support group (zoom meetings mostly), and Duet Caregivers and Grandparent's. groups. Discussions are active to bring back a mental health support group that met here before the pandemic.

The **CELC Outreach Food Pantry** is affiliated with St. Mary's Food Bank which is also a part of the Feeding America program. The CELC food pantry is fully licensed by Maricopa County, and we continue to receive an "A" rating on our twice-yearly kitchen/pantry inspections. St. Mary's also inspects our kitchen and pantry annually.

The CELC Outreach Ministry through its Tuesday food distribution program provided over **3,331 food boxes** (avg 67 per week) and provided food for over **16,194 individuals** during this past year. These boxes provided food for an average of 278 families per month plus emergency boxes for members in our community. In 2024, CELC experienced a 1% decrease in the number of households served, and a 2% increase in the number of individuals served over 2023.

Outreach income for the year was **\$27,670** and expenses were **\$21,328**. We were able to move some money to the Outreach Designated Fund at the end of year. Food was purchased weekly from St. Mary's Food Bank, to supplement the donations received. We distributed food from St. Mary's -- 153798.14 lbs., Basha's - 13,128 lbs., Panera - 8812 lbs., Wildflower - 3310.46 lbs., and over 7200 lbs. from our congregation and community. The 2024 Souper Bowl event raised \$440, and the 2024 March Madness Cereal Bowl raised \$88 (+62 boxes of cereal) for our food pantry. Cheerios took top honors for the 3<sup>rd</sup> year in a row, but the big win goes to our Outreach food pantry families.

**43 volunteers** showed up regularly to set up tables, weigh, sort, and store food, register households, fill boxes, drive to St. Mary's weekly, pick-up food from our grocery rescue partners (Panera and Basha's), clean and sanitize tables and the kitchen equipment, direct traffic in the parking lot, and distribute boxes.

This year, we gained two new business partners. Employees from Target volunteered in July and December, helping us fill boxes, unload food from the van after its morning trip to SMFB, and distribute boxes to cars. Amazon Fulfillment conducted a food drive in November and delivered 93.75 lbs. of food in early December. Lennox Industries collected and donated 315 lbs. of food Thanksgiving week. Prime Solutions Group, Inc. (PSG), adopted one of our Outreach families for Christmas and provided them with gifts. We look forward to partnering with these companies in 2025.

**Tuesday Boutique sales** of donated furniture, clothes and household items totaled more than \$4200. Funds were used to purchase supplies and food for the program. Special thanks to Ardyce Durand and several volunteers for sorting, pricing, and selling the donated goods.

In coordination with Kathy Williams, Health Coordinator, Outreach provided adult hygiene products once a month (first Tuesday of month when available) to our Outreach households and I-HELP participants. We just learned that CELC has been awarded a grant of \$2500 from the West Valley Lutheran Thrift Shop to help us with this effort. Once the funds are received, we will stock our shelves and prepare for monthly distribution. **It will be a good start to 2025.**

#### 2023 Financial Audit report

From: Financial Audit Committee Subject: Financial Audit of CELC Finances for 2023 Date: 01 May 2024

The 2023 Financial Audit Committee included three CELC members: Keith Lefevre, Janell Jenson, and Darrel Bjornson (Chairperson). As the chairperson of the Committee, I want to thank Keith and Janell for agreeing to serve on the Committee. We had a brief meeting in March 2024 and discussed how to proceed with the audit. As in past years, we each were going to pick up two months' worth of financial documents and one month of the credit card documents from Ann Bruce. Ann brought the documents to the Sunday Service. Darrel's assigned financial documents were for March 2023 and August 2023 and his credit card documents were for September 2023. Keith's financial documents were for February 2023 and September 2023 and his credit card documents were for March 2023. Janell's financial documents were for April 2023 and December 2023.

A financial audit is an objective examination and evaluation of the financial statements to make sure that the financial records are a fair and accurate representation of the transactions they claim to represent. The members of the committee were not professional auditors. Hence, the charge of the committee was to review the documents and mostly look for process issues that may need to be improved upon in the church finances. It would be unlikely that we would find any accounting errors but, if we did, we were to address them with the CELC Financial Team. To be honest, we mostly looked for odd or out of the ordinary things.

We reviewed all Sunday credits to the bank account for the months we were assigned. This included the checks (loose plate checks and envelope checks) and cash (envelope cash and loose plate cash). The deposit for the total in each instance was validated with the adding machine tape, the documentation of the counters and the VANCO documents. The financial team members and volunteers who performed this task each Sunday are to be commended for their time, diligence, and accuracy in insuring these deposits were appropriately handled.

There were several questions raised by the Audit Committee concerning the Chase Business Total Savings account, the Profit and Loss Statement – Budget vs. Actual, and the Account Summary. To be fair, most of these questions were raised because of our inability to fully understand these documents. The questions raised by the Audit Committee regarding these monthly financial documents were appropriately explained and answered by the CELC Financial Team to the satisfaction of the Committee.

There were some questions regarding the use, along with the authorization to use, the myriad of separate fund categories (e.g., Legacy, Kitchen, Memorial, Solar). The Financial Team explained how these funds have now

been consolidated into Designated Funds and require Council approval if requests to spend the Funds exceed a certain amount. There was also some discussion about the awareness of the Congregation regarding the financial benefits of using the Fry's account (and in the past, the Amazon account) to benefit the Church. It was suggested that this type of information should be more widely disseminated to the Congregation, either verbally or electronically.

There was, however, one area of concern which should be addressed regarding the use of the church credit card. Issues regarding the use of the church credit card have been raised in past audits. To be clear, the Committee did not feel there was inappropriate use of the credit card nor was the security of the credit card in question. However, there were issues related to documentation and the use of the Purchase Authorization Form. In a review of the March 2023 and September 2023 credit card documents, there were 23 total credit card charges. Of those 23, over half (13) had not been approved on the Purchase Authorization Form and two Authorization Forms were missing and presumed not filled out. Two credit card charges had been requested and approved by the same person. All of the charges were correctly coded with the church account codes. The recommendation from the Audit Committee would be that those using the credit card and those authorizing its use ensure its proper use.

The committee believes that the finances of the church were being handled appropriately in a competent and professional manner. After reviewing the documents, it is clear that the effort to manage the church finances is a difficult job and the volunteers are to be commended. The committee acknowledges and appreciates the time and effort put in by the CELC Financial Team: John Brown, Ann Bruce, Sharoll Blodget and other volunteers.
